## ParentRequesting an IRSerification of Non-Filing Letter

An IRS Verification of Netiling Letter provides proof that the IRS has no record of a filed Form 1040 for the year you requested. Non Tax filers can request an IRS Verification efilting of their 2021 tax return status, free of charge, from the IRS by following the steps below:

- x Complete lines 1t 4 with the non-filers information, following the instructions on page 2 of the form.
- x Line 5: Leave this section blaukless you have a Customer File Number
- x Line 6: Leave this section blank.
- x Line 7: Select the checkbox on the right hand side for Verification of **filing**.
- x Line 8: Leave this secti blank.
- x Line 9: Year or period requested field, enter "12/2021".
- x The nonfiler must sign and date the form and enter their telephone number. Only one signature is required when requesting a joint IRS Verification of **Nion** Letter.
- x Be sure to reiew and check the box above the signature section.
- x Mail or fax the completed IRS Form 45060 the address (or FAX number) provided on page 2 of Form 4506T. If the 4506T information is successfully validate with a complete to receive a paper IRS Verification of Nonfiling Letter at the address provided on their request within 5 to 10 days.

Once you have received your Verification of **Niting** letter, attach it to your completed and sign 2023-2024 Parent NonTax Filer Statement and fax or mail boltbcuments to the Stevenson University Financial Aid office.
